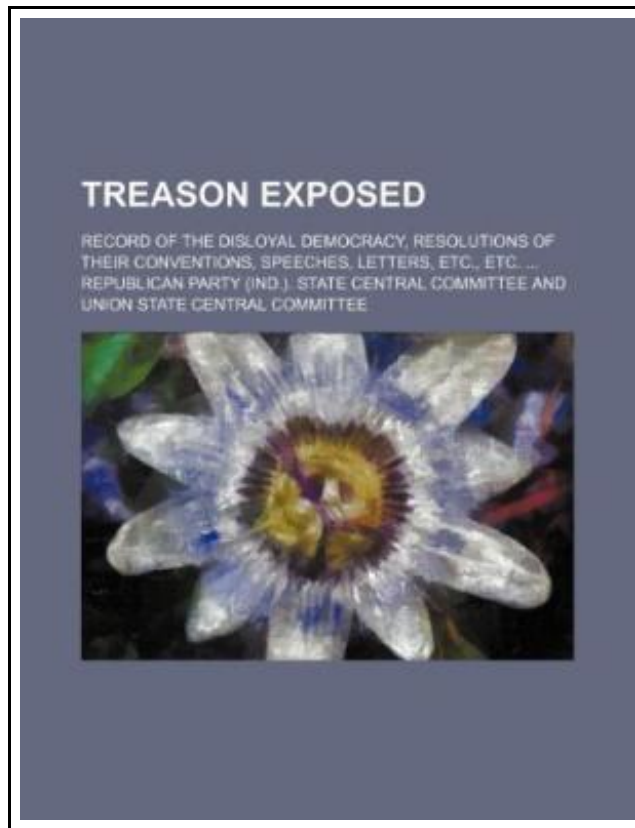

The Convention was addressed by Judge Perkins, the editor of the Indianapolis Daily Herald, and it is understood that he is the author of the resolutions: Resolved, That we are opposed to, and earnestly protest against, the nomination of a war Democrat for the Presidency, believing that the present deplorable war can not be prosecuted, except in violation of the spirit and principles of the Constitution, and in opposition to the doctrines which distinguished the Democratic party. Resolved, That the Democracy can not. introduce a war plank into their national platform without a sacrifice of their principles, and can not proclaim a war policy without asking the people to believe a lie that they may be damned. Resolved, That every man calling himself a Democrat should, in view of the present issues, now boldly avow their principles, fearlessly avow his sentiments, and signify to all whom it may concern that, if there should be no other way left, he will defend them with his good broad sword and strong right arm. Resolved, That the Democracy of Martin county, Indiana, do not hold themselves bound to support any man for the Presidency, or any other office,...
