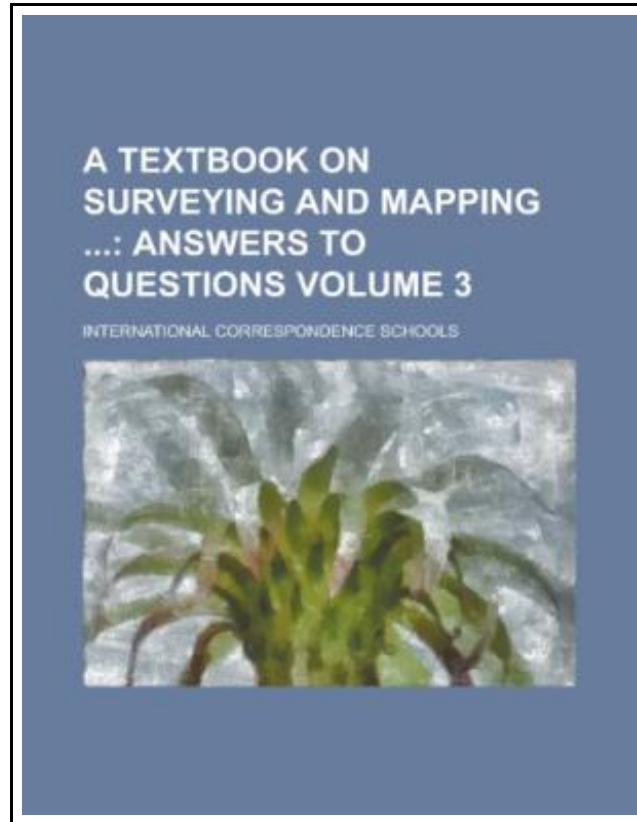

Table 1 shows that a higher estimated percentage of taxpayers misreported a securities sale than a capital gains distribution. Overall, an estimated 7. 3 million out of an estimated 20. 3 million taxpayers misreported their securities sales compared to the estimated 1. 2 million out of an estimated 18 9. 1 million taxpayers who misreported their capital gain distributions. One reason taxpayers may misreport securities sales more frequently is that taxpayers must compute the portion of their sales proceeds that constitutes a gain or loss, whereas taxpayers need only add up their capital gain distributions from information returns they receive and enter the amounts on their tax returns. Table 1 also shows that individual taxpayers are estimated to have misreported their short-term securities sales about as often as their long-term sales.
